

# Senate Bill 1042

Sponsored by Senator PROZANSKI

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Authorizes Governor to enter into agreement with another state for purpose of cross-jurisdictional coordination and enforcement of marijuana-related businesses. Specifies that under laws of other state, production, processing, sale and testing of marijuana items must be lawful. Specifies that borders of this state must abut borders of other state. Prohibits transporting marijuana items through use of navigable airspace, through use of any mode of transportation subject solely to federal regulation and through any state or territory of United States that is not party to agreement.

## A BILL FOR AN ACT

2 Relating to cannabis.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. Section 2 of this 2017 Act is added to and made a part of ORS 475B.010 to**  
5 **475B.395.**

6 **SECTION 2. (1) The Governor, or the Governor's designee, may enter into an agreement**  
7 **with another state for the purpose of cross-jurisdictional coordination and enforcement of**  
8 **marijuana-related businesses licensed to conduct business in either this state or the other**  
9 **state, provided that:**

10 (a) **Under the laws of the other state, the production, processing, sale and testing of**  
11 **marijuana items is lawful;**

12 (b) **The borders of this state abut the borders of the other state; and**

13 (c) **With respect to the cross-jurisdictional transportation of marijuana items, the**  
14 **agreement prohibits:**

15 (A) **The use of navigable airspace;**

16 (B) **The use of any mode of transportation subject solely to federal regulation; and**

17 (C) **The transportation of marijuana items through any state or territory of the United**  
18 **States that is not party to the agreement.**

19 (2) **An agreement entered into under this section:**

20 (a) **May provide for the cross-jurisdictional coordination and enforcement of marijuana**  
21 **producers, marijuana processors, marijuana wholesalers, marijuana retailers, marijuana**  
22 **testing laboratories and other lawful producers, processors, sellers and testers of marijuana**  
23 **items that are licensed or otherwise authorized to engage in the activity of producing, pro-**  
24 **cessing, selling or testing marijuana items in either this state or the other state.**

25 (b) **May require the other state to establish the same or similar requirements on**  
26 **marijuana producers, marijuana processors, marijuana wholesalers, marijuana retailers,**  
27 **marijuana testing laboratories and other lawful producers, processors, sellers and testers of**  
28 **marijuana items that are consistent with the policies set forth in:**

- 1       **(A) ORS 475B.010 to 475B.395;**
- 2       **(B) ORS 475B.400 to 475B.525;**
- 3       **(C) ORS 475B.550 to 475B.590; and**
- 4       **(D) ORS 475B.600 to 475B.655.**

5       **(e) Must ensure enforceable public health and safety standards and include a system to**  
6 **regulate and track the purchase, sale, production, processing, transportation and delivery**  
7 **of marijuana items for marijuana producers, marijuana processors, marijuana wholesalers,**  
8 **marijuana retailers, marijuana testing laboratories and other lawful producers, processors,**  
9 **sellers and testers of marijuana items that are licensed or otherwise authorized to engage**  
10 **in the activity of producing, processing, selling or testing marijuana items by the other state.**

11       **(d) May authorize an agency of this state to assist in the implementation and enforce-**  
12 **ment of the terms of the agreement.**
